- Our boats have an occupancy limit of 12 people, including children(with the exception of our Double-Decker pontoon which is a limit of 14).

2. Assumption of Risk, Release of Liability, and Indemnity Form

 We have enclosed 12 (14 for our double-decker pontoon) forms for your use. One form must be filled out for each person boarding the boat with you. If children are accompanying you, please fill out a separate form for each child.

3. Markel Marine Insurance Form

Completing ALL documents prior to arrival will speed up the process and get you out on the water at your reservation time.

NOTE: Our boats have 12 adult life jackets (14 on Double-Decker pontoon) and 4 children's life jackets.

WE DO NOT HAVE INFANT LIFE JACKETS AND YOU WILL NEED TO PROVIDE A LIFE JACKET FOR ANY CHILD UNDER 50 LBS.

PLEASE ARRIVE <u>15 MINUTES BEFORE RENTAL TIME</u> TO COMPLETE ORIENTATION.

Important Notes:

- Renters are responsible for the cost of gas used during their rental period.
- Renters are responsible for all damages incurred during their rental period.
- There is a \$50 per pet fee to bring a pet aboard your rental
- Absolutely no grills are allowed on boats
- On the day of the rental reservation, the driver of the boat is required to bring a valid driver's license and a valid credit card (debit cards are not acceptable). If these two cards are not available the day of the rental, then we cannot send out the rental or fix the charges on the credit card.
- Boats cannot be taken farther upstream than Flynn's Lick Recreation Area and no farther downstream than the Cordell Hull Dam. Always maintain a 50-yard distance between the boat and the Dam.
- Anyone renting the double-decker pontoon understands that NO ONE is allowed on the top level while the boat is moving.
- No one can be towed on a tube in any wake zone or in the marina.

Damages:

- Renters are responsible for all damages incurred during their rental period up to \$1000.
- Props damaged are assessed at \$300.
- Any damage will be estimated and charged to your \$1000 security deposit immediately after the return of the boat.
- Refusal to pay for damages assessed will result in immediate notification to all credit reporting agencies and we will file suit with small claims court where you will be required to pay our attorney's fees and court costs in addition to the charge for the actual damage. You will also be banned from ever renting our equipment in the future.
- If you do not agree with our assessed damage cost, we will charge the entire \$1000 and have the damages professionally assessed. If you are due a refund we will immediately refund your card.
- Quite often, our assessment is less than the professional assessment we receive, therefore, it may be in your best interest to pay for the damage assessed on-site.

General boating safety

1. Maintaining safe speed/monitor surroundings/drive defensively/no aggressive maneuvers

- 2. Maintaining a safe distance from other boats, objects and people
- 3. Do not enter the water without a lifejacket on, engine turned off and key removed
- 4. Conduct a head count before starting the engine
- 5. Always remain seated while the boat is in motion
- 6. Absolutely no sitting on the bow, sides or stern
- 7. Importance of attaching the engine shut-off cord/lanyard
- 8. Engine start and shut-off procedures
- 9. Dangers of CO2
- 10. Refueling procedures and engine blower use (if applicable)
- 11. Sound five blasts of the horn or whistle to signal danger or need for assistance
